RE: ENGAGEMENT OF AGENTS FOR CLEARING NDSO COMMODITIES

The National Drug Service Organization (NDSO) is a Trading Account for the Ministry of Health in Lesotho. It is mandated to **procure, store and distribute** Medicines, Medical Supplies and Laboratory Consumables for the Health Institutions in Lesotho. NDSO is legally Gazetted through the Legal Notice Supplement No.4 to Gazette No.19 of the 2nd March 2007. The Government Hospitals use their allocated funds for Medicines and Medical suppliers to buy the supplies from NDSO.

In order to manage the risk of fraud and error on NDSO Credit account with the Lesotho revenue authorities, used for clearing the goods at the border, NDSO requests your company to submit the full contact details of your approved clearing agents who handles the declaration of your goods into our country (Lesotho). The exercise is intended to appoint few approved clearing agents that will be given access to NDSO LRA Credit Account for clearing purposes in order to block unwanted access. This will ensure better control of our LRA Credit account and will assist in timely and accurate account reconciliations.

The few approved clearing agents will be communicated to all stakeholders accordingly and all NDSO suppliers will be expected to only use them. Kindly provide the information on or before Thursday, 17 February 2022.
